What has happened

New Zealand Certificate in Irrigation Installation (Level 3) and the New Zealand Certificate in Irrigation Engineering (Level 4) will be discontinued and replaced by new qualifications.

The new qualifications have the following changes:

- Wording changes to the titles to better reflect the intention of the qualification.
- Wording changes to the purpose statements to better reflect the intention of the qualification.

The New Zealand Certificate in Irrigation Installation (Level 3) credit value reduced from 140 to 65 to support learner needs and provision for industry.

The New Zealand Certificate in Irrigation Engineering (Level 4) credit value reduced from 135 to 70 to support learner needs and provision for industry.

- Qualifications' core GPOs reworded to better reflect industry requirements.

What has happened

Strategic Purpose Statement updated to include meat ‘processing’ and ‘food processing’ to broaden scope and capture other sectors.

Graduate Profile Outcomes (GPOs)(core) changed to include the wider sectors of meat processing and meat product manufacturing.

Grading strand credit value reduced from 40 to 20. This credit reduction has had no impact on the overall credit range of the qualification

What has happened

- Unit standard 17693's title was changed, a prerequisite was added, and outcome 4 was updated.

- Range statements and performance criteria were updated in unit standards 15662, 30898 and 30899.
- Titles were changed in unit standards 15666, and 30899.

- Unit standard 30772 and 9918 updated to include additional Performance Criteria and updates to existing outcomes and PCs were made.
- The titles of unit standards 18163, 23249, 23257, 25344, 29238, 30204, 30771, 30772, 30781, 31200, 31202 and 9918 were amended to align with the contents of the standards.
- A shift in terminology across all unit standards from the words trailer boat to power boat to include all on water boats, not just boats that can go onto a trailer.

What has happened

- Coversheet titles were updated to align with the new operational excellence terminology.
- A definition for operational excellence was added across the NZQA coversheets linking the operational excellence and competitive systems and practices wording.
- Coversheets were updated to include a reference to the Australian DEWR approval to use Australian standards.
- Manufacturing Industry Skills Alliance was added to each coversheet as the new developer of the Australian UOCs.
- Links to the new training.govt.au website were updated across the coversheets and the UOC code was updated where the Australian version has changed.
- Unit standard 24781 was changed from Level 4 to Level 5 due to changes to the performance criteria in the UOC, which now includes a strategic and cross-organisation focus.
- Four unit standards are expiring on the NZQCF in line with the review of UOCs on the Australian Framework. The expiring unit standards: 24790, 24792, 24800 and 24804 are listed in the table below.
- The reference to the Australian training package was updated from MSS11 to MSS.
